



# TRANSPORTATION BENEFITS

## ***Use pre-tax dollars for commuter and parking expenses***

With a Transportation Account, employees establish a pre-tax account on a month-by-month basis to pay for qualified work-related commuting and/or parking expenses:

- **Public Transportation** (bus, train, ferry, subway)
- **Vanpools**
- **Commuter Highway Vehicles**
- **Contract Parking**

Depending on your tax bracket, you can save up to **40%** on your commuting and parking costs by using pre-tax dollars - a *significant tax savings* (income and Social Security taxes).

You will also benefit from the convenience of online enrollment, home delivery of the commuting passes/tickets, and the flexibility of monthly participation.

***No more waiting in line to buy tickets!***  
***No more waiting for reimbursements!***

You may sign up for a transportation account any anytime throughout the year and discontinue at anytime. Purchases are made online per month through pre-tax payroll deduction and passes/tickets are mailed directly to you. You have the option to set up a recurring monthly purchase and receive e-mail reminders to notify you of an upcoming purchase.

## Requirements

- Eligible commuter expenses must be work-related.
- Eligible parking expenses must include parking at or near your place of employment, or at a location from which you commute to work.

### Savings Example A:

If you have a combined (local, state, federal) tax rate of 40% and spend \$105 per month on your bus pass, you will save \$42! That means your train pass now costs only \$63. Over the course of a year, you will save \$504. That's almost five months free!

### Savings Example B:

You park and ride, paying \$95 for your train ticket and \$175 for your parking pass monthly. Your combined tax rate is 35%. You save over \$33 per month on your train ticket PLUS another \$61 per month on your parking expenses. That's a savings of almost \$100/month!
